The Hon. Secretary then read out the Notice of the meeting.

1.0: <u>Receipt and approval the Minutes of the 28th AGM - 19th November 2017</u>

The President asked if everyone was happy with the accuracy of the previous minutes.

2.0: Receipt and consideration of the Annual Report

Geoff Durbin (GD) expressed his thanks to the Officers and Staff of the Association for their help and support during the last year. GD said he was grateful to England Athletics (EA) for their grant and mentioned the other main sponsors, Derby Runner for the Cross Country Numbers, Athletics Direct for providing the numbers for the Track and Field competitions and the Track and Field League itself. This coming year Athletics Direct will continue to support us by sponsoring 75% of all the numbers. GD also thanked ECCA and ERRA for their funding which helps development.

GD said that the Association will try to continue to work with England Athletics with regards to funding. The scheme now in place with Northern Athletics has begun to throw up some problems, such as the disenfranchisement of any Northern born athlete who no longer lives in the north and so would not be able to compete in the Northern Championships. After discussion with Chris Jones of England Athletics and consultation with John Gandee, Chairman of the Southern Athletics Competition Committee, the Midlands Area and Southern Area will resubmit their original proposal that EA act as central point of collection of a proposed £3 fee to go directly to the two Areas. The original submission was 'misunderstood' by the EA Board.

Stuart Albutt, (Solihull and Small Heath), said that he had heard that the South was considering becoming autonomous. GD again re-iterated that he had been talking with the Competition Board Chairman of the South and that this was not mentioned.

Keith Brackstone and Roger Brockelsby (Bristol and West), expressed concerns with the way that both UKA and EA were treating the Areas and Clubs and also that UKA wanted to subsume the Home Countries Associations, so they controlled everything. Much discussion followed revolving around these points, with agreement in many areas and with a promise that the Midlands will continue to work towards ensuring adequate funding for the sport.

Andrew Hulse then gave his report outlining the changes which had occurred during the year. Bunny Kyd (Royal Sutton Coldfield) asked about the position and future of facilities in this and other areas. Discussion followed where Track Mark and the problem of Throwing cages were covered.

The Annual Report was accepted by the meeting.

3.0: Receipt and adoption of the Accounts and Financial Report

Stewart Barnes (SB), (Hon. Treasurer) then gave his Financial Report. Bunny Kyd (Royal Sutton Coldfield), asked about the amount of Bank Charges. This was discussed and SB suggested this was normal transaction charges and also PayPal charges. SB will investigate this further and reply to the questioner.

Motion to accept the Accounts and Financial Report was proposed by Iris Morris and seconded by Stuart Albutt. This was passed unanimously.

Stewart thanked the office staff and Mrs. Valerie Day for all the work they had done to support him.

Geoff Durbin then explained that he would be standing down as Chairman after 18 years at next years AGM, hence his nomination as President-Elect. He stated that he would strive to ensure funding was secure.
